A. FY 2023-2026 TIP Amendments

Alec Miller explained the one TIP amendment.

JN: 219499 is a new job for MAX Transit focused on planning services – specifically, MAX’s new route study.

C. LRTP – Chapters

Chapters Five, Six, and Seven were brought to the TAC. It was discussed that the chapter six M-231 section should be rewritten including comments from TAC members and then sent back out for approval.

Kait Riegling made a **MOTION** to approve LRTP Chapters Five and Seven, **SUPPORTED** by Mike Sabatino. **MOTION PASSED.**

D. Reconnecting Communities Grant

Eric Dykstra and Jason Latham explained the MACC's intention to seek the Reconnecting Communities Grant (RCG) for the I-196 BL Pedestrian Bridge project. Jason clarified that although the project is still in its early stages of cost estimation/funding, it aligns with the RCG's provisions for projects without finalized funding. The grant application deadline is set for the end of September, and there is an awareness that the MACC may not secure it this time, but anticipates valuable feedback to enhance future applications. Notably, both the City of Zeeland and Zeeland Charter Township expressed their support for this endeavor.

Brett Laughlin made a **MOTION** to suggest that the MACC pursues the Reconnecting Communities Grant. **SUPPORTED** by Steve Bulthuis. **MOTION PASSED.**

6. COMMENTS BY MDOT

Matt Block explained that I-196 and Bryon Road are to open in mid-late October and have traffic back on their normal sides. Blue Star Highway bridge is open at exit 41. SB on US-

31 is also officially done.

7. COMMENTS BY MACC STAFF

Alec Miller showed the website and how to use the Green Commute Week form – already over 50 submissions. Velo City stopped by the MACC and gave us 2 gift cards to give away, along with some t-shirts and hats.

Eric Dykstra mentioned that later this month he will be going to the AMPO Conference in Cleveland, OH at the end of this month. Jason is also doing a leadership program this week. He also led an AMPO discussion at a national web conference.

The MACC also held a successful BL I-196 stakeholder meeting this past week.

8. MACC MEMBER REPORTS / STATUS OF CURRENT PROJECTS

Olive Township – concerned that the state wants to take over solar and wind control.

MAX Transit – currently doing the Route Study and had the first stakeholder meeting the other week. There also will soon be surveys on the MAX website. October 24th at Evergreen Commons will be the first of three open-house public engagement events.

City of Holland – Dual left at M-40 and Waverly was recently obligated. CoH is playing to close VanRaalte and detour traffic for a month.

ACRC – 146th Ave W of 48th is on schedule for a mid-October completion.

City of Zeeland – moving into block two of their Main Street project. Opened the section in front of the school.

OCRC – 8th / Chicago is still underway. 64th Ave just started and should be done in a couple of weeks.

Holland Charter Township – 8th / Chicago is moving along. Greenly Path from 120th to 112th will be starting soon and should be finished in early November.
